A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, RECITING THE FACT OF THE PRESIDENTIAL GENERAL ELECTION HELD ON NOVEMBER 8, 2016 BY DECLARING THE RESULTS AND CERTAIN OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Rialto, California, on Tuesday, November 8, 2016, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the Elections Code of the State of California for the holding of elections in General Law Cities; and

WHEREAS, pursuant to Resolution No. 6941 adopted May 10, 2016, the San Bernardino County Registrar of Voters Office canvassed the returns of the election and has certified to the City Council, the results are received, attached and made a part hereof as “Exhibit A.”

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the total number of votes cast in the City of Rialto was 27,785.

SECTION 2. That the names of the persons voted for at the election for are as follows:

SECTION 3. That the Rialto City Council does declare and determine that Mayor Deborah Robertson was elected as Mayor for a full term of four years; Andy Carrizales was elected as a Member of the City Council for a full term of four years; Rafael Trujillo was elected as a Member of the City Council for a full term of four years; City Clerk Barbara A. McGee was elected as City Clerk for a full term of four years; and City Treasurer Edward J. Carrillo was elected as City Treasurer for a full term of four years.

SECTION 7. The City Clerk shall have on the record of the City Council of the City, a statement of the results of the election, showing: (1) The whole number of votes cast in the City; (2) The names of the persons/measure voted for; (3) For what office each person was voted for; (4) The number of votes given at each precinct for each person; and (5) The total number of votes given to each person.

SECTION 8. The City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall

1 administer to each person elected the Oath of Office prescribed in the Constitution of the State of
2 California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of
3 the persons so elected shall then be inducted into the respective office to which they have been elected.

4 **SECTION 9.** That the City Clerk shall certify to the passage and adoption of this resolution
5 and enter it into the book of original resolutions.
