

Finance

The Finance Division will present the final Interim Report for Fiscal Year 2014-15 to the City Council in August. Audit adjustments and accruals that are yet to be receipted or expended, if not already encumbered, are omitted from the final Interim Report and will be processed and presented in the audited financial reports. Finance Division staff have met with the City's auditors to discuss the audit timeline and the goals and objectives for the FY 2014-2015 audit. The Fiscal Year 2014-2015 interim audit fieldwork commenced July 20, 2015, and was completed July 23, 2015. Year-End audit fieldwork is expected to start in mid-October. The City's objective is to finalize the FY 2014-2015 audit by December 31, 2015, and present the audited financial reports to City Council in January 2016.

Tom Sawyer Swimming Pool

Our Water Safety Instructor team has done a great job this summer with preparing swimmers for summer activities. Participants receive water safety instruction as well as demonstrations on how to improve their stroke and overall swimming technique. Our private and group swim lessons are filling up as soon as registration opens. Staff has facilitated the addition of beginning level classes as needed and has scheduled private lessons as quickly as possible. Currently we have 20 private lesson enrollees and 131 Learn 2 Swim participants.



Our recreational swim attendance was 1,515 as of July 28th and will increase toward the end of the month with 7 more recreation swim sessions the remainder of this week. June. Our Summer Fun Saturdays have been well attended with Saturday being our busiest recreation swim day of the week. Families get an added bonus to their rec swim

at no additional charge aside from snacks. Pool staff host fun games on deck and in the water where participants can win small prizes and a chance to win free recreation swim passes. There is one more Summer Fun Saturday August 22nd. Come out, join the fun and get a chance to meet our amazing lifeguards.

Staff and pool users are happy with the updated locker room floor, paint and shower fixtures. We are anticipating the resurfacing of the pool deck which is scheduled to begin in October.

July 2015 has been an exciting month for Fit4Kids! Fit4Kids is currently in the final week of our Sports and Fitness Summer Camp at the Rialto Racquet and Fitness Center. Development Services Department

Airport Redevelopment Update

- **Demolition/Remediation.** The City contracted with West Tech Contracting for the final phase of the demolition and remediation work, removing the asphalt and concrete and conducting any required soil remediation. Work commencement is pending passive relocation of the burrowing owl nests discovered in the area of work. The contractor has been directed to schedule commencement predicated upon a September 1, 2015 clearance date for the fledgling owls.

- **SBIA Improvements.** The Sheriff Aviation Facility and the General Aviation improvements at SBIA proceed, with hangar deliveries scheduled late this year and into 2016.



The concrete tilt up walls have been raised for the new County Sheriff Aviation Facility under construction at the San Bernardino International Airport. The County Sheriff Aviation Facility is the centerpiece of the general aviation component.

- **Public Improvements.** The Miro Way Improvement Project proceeds rapidly. The sewer line from Alder Avenue to Linden Avenue, then south to Baseline Road has been completed and is undergoing integrity testing. The street improvement bids were awarded and rough grading and survey work commenced. Fontana Water Company commenced installation of a water main in Linden Avenue and Miro Way. Finally, the storm drain work is proceeding through Jerry Eaves Park towards Ayala Drive.

The City approved conditions of approval for the Emhart Industries treatment plant at the northeast corner of Linden Avenue and Miro Way. Emhart will install a well on the north side of Jerry Eaves Park, and pipe the perchlorate laden water to the treatment facility. After treatment, the water will be delivered to the City of Rialto by construction of a water line in Linden Avenue. Construction will start during September, so that the trenches in Ayala Drive and Linden Avenue can be permanently patched with the subsequent street improvement projects.



The storm drain pipes are lined up for installation across Jerry Eaves Park. The storm drain will divert water from the watershed north of Miro Way to the Cactus Basins, ultimately alleviating some of the flooding that regularly occurs on Baseline Road.

Industrial Project Report

The City receives quarterly reports from various real estate brokerages regarding industrial sales and leasing activity in the Inland Empire. For the second quarter of 2015, Jones Lang LaSalle reports that the aggressive leasing activity in the Inland Empire has caused vacancy rates to decline and rents and values to correspondingly increase. The vacancy rate is at 5.2% within the Inland Empire for buildings larger than 100,000 square feet.

The City of Rialto shares in this activity, with the following lease and sale transactions recently reported:

- **Keeco** leased and now occupies the 677,225 square foot building constructed by Prologis on Tamarind Avenue to distribute linen, bedding, bath and window treatments products.
- **Distribution Alternatives** has leased 616,000 square feet of the 928,000 square foot DCT Industrial Center on Renaissance Parkway. DCT is seeking tenants for the remaining 312,000 square feet. Distribution Alternatives is a third party logistics (“3PL”) provider serving Target and other retailers.
- **Solomon Colors** purchased the 100,000 square foot building at 1371 North Laurel Avenue for \$8.5 million, reflecting \$85 per square foot of building area. Solomon Colors also owns a facility at 360 South Lilac Avenue in Rialto.

Retail Chatter

- **McDonald’s.** Construction of the new McDonald’s located at 1308 West Foothill Boulevard rapidly moves toward completion in September.
- **Chevron.** The 210 Petroleum Partners broke ground on a new Chevron gas Station located at 2035 N. Riverside Avenue in the Shoppes at Creekside development located north of the 210 Freeway. The new gas station includes 6 fueling positions, a 3,235 square foot convenience market and a car wash.
- **Tacos El Gavilan.** On July 23rd, Tacos El Gavilan held its grand opening ceremony at its newest location at 115 East Baseline Road. Rialto is the seventh location for the restaurant, with other outlets in Azusa, Bell, Downey, Hollywood, Huntington Park, and Los Angeles. The restaurant offers “authentic Mexican cuisine”, with quality food and service.



Planning Commission Summary

The Planning Commission reviewed the following projects in July:

- **Conditional Development Permit No. 769 & Variance No. 709.** The Planning Commission directed staff to prepare a resolution to deny the request to allow the issuance of a Type 21 (Off-Sale General) liquor license from the California Department of Alcoholic Beverage Control for the sale of general alcoholic beverages at an existing convenience market at 509 West Foothill Boulevard. The Commission also denied a request to reduce the required separation distance between establishments offering alcoholic beverages for sale for off-site consumption and various sensitive uses.
- **I-210 Logistics Center III Distribution Facility.** The Planning Commission recommended approval of the Addendum to the Renaissance Specific Plan Environmental Impact Report and Amendment No. 4 to The Renaissance Specific Plan to change the zoning of a 1.3 acre site from Utilities/Public Facilities to Employment Zone; Variance No. 710 to vary from the setback requirement for lots in the Employment Zone; Tentative Parcel Map No. 19649 to consolidate 23 parcels of land and create one parcel of land; Lot Line Adjustment No. 224 to adjust the property lines between contiguous parcels and create a 0.55 acre parcel for the proposed church; Conditional Development Permit No. 773 to locate a church sanctuary in the employment zone; Precise Plan Of Design No's. 2399 & 2400 to construct an approximately 2,264 square foot church and a 742,514 square foot warehouse; and Development Agreement No. 15-01.
- **Conditional Development Permit No. 772.** The Planning Commission approved a request to allow an eight percent (8%) increase in the permitted floor area ratio through the implementation of non-residential development incentives for the development of a 175,900 square foot industrial warehouse building on a 8.42 acre site located at the northeast corner of Base Line Road and Laurel Avenue within the EMP (Employment) zone of the Renaissance Specific Plan. A Mitigated Negative Declaration (Environmental Assessment No. 15-27) was prepared for the project. This item was continued to the August 26, 2015 Planning Commission meeting at the request of the applicant.

During the month of July, the Planning Division reviewed 15 site plans for future development projects including the following notables:

- **R.C. Hobbs Company, Inc.** Development of a detached single-family residential subdivision on approximately 4.57 acres of land located at the southwest corner of Bloomington Avenue and Willow Avenue.
- **R.C. Hobbs Company, Inc.** Development of a 44 unit apartment complex on approximately 2.1 acres of land located on the south side of Foothill Boulevard approximately 300 feet west of Spruce Avenue.
- **Fernando Acosta.** Development of a shopping center on approximately 5.82 acres of land located at the southeast corner of Riverside Avenue and Locust Avenue.

- **Azure Route 66.** Development of a 214 unit senior congregate care facility on approximately 8.19 acres of land located on the north side of Foothill Boulevard approximately 200 feet east of Acacia Avenue.
- **ZoZo Community, Inc.** Development of a 5 unit apartment building on 0.32 acres of land located at the southwest corner of First Street and Date Avenue.
- **Fountainhead Development, Inc.** Development of a 1,900 square foot retail/food building with a drive-thru on 0.48 acres of land located at the southeast corner of Riverside Avenue and Easton Street.

Building Division Report

During the month of July, 2015 the Building Division provided the following services:

- Counter Services. There was 362 counter assists, and 11 over the counter reviews.
- Plancheck Submittals. 74 plans were submitted for plancheck, and 27 of those were completed in-house.
- Plancheck Approvals. The Building Division approved 75 plans for permit issuance, primarily for solar installations and tenant improvement projects. The average review period for first plan check was 7.5 business days.
- Building Permits Issued. The Building Division issued 200 building permits collecting \$319,970 in plancheck and permit receipts.
- Development Impact Fees Collected. The Building Division collected \$2,516,496 in development impact fees. The largest payees were Panattoni Development (for the I-210 Logistics II Center), the County of San Bernardino (for its Bloomington Mixed Use Project), and CapRock Partners.
- Building Inspections. The City's building inspectors performed 516 inspections, with 333 stops, or 30 inspections per working day along with 19 stops a day.
- Final Certificates of Occupancy. The Building Division issued final certificates of occupancy for a total of 9 projects.

Code Enforcement Services

The Code Enforcement Division received 50 new complaints during the month of July, issued 142 Notices of Violation, 3 Administrative Citations, assessed \$33,750 in fines, and issued 5 Court Citations. Code Enforcement received 60 calls and 36 counter inquiries. Ninety-two cases were resolved this month with homeowners and businesses alike. Through explaining and educating the citizens about the Rialto Municipal Code, together we were able to enhance the city.

Housing Authority and Redevelopment Successor Agency

AB 113 Negatively Impacts the City of Rialto

The State Legislature is considering AB 113 that amends the Redevelopment Dissolution Act. AB 113 has several deleterious provisions, including invalidating reimbursement agreements between the City and its former Redevelopment Agency. In 2010, the City and the former Redevelopment Agency executed a cooperation agreement entitling the City to recover \$5 million plus interest related to the Cactus Channel improvements. The City has registered its opposition with State Senator Connie Leyva and Assembly Member Cheryl Brown.

Housing Authority Purchases Site for Future Affordable Housing Project

On July 28, 2015, the Rialto Housing Authority approved the purchase of two parcels totaling 2.55 acres for the amount of \$910,000. The site is located on Bonnie View Drive, just west of Riverside Avenue and south of the Metrolink Station. The City proposes to partner with a non-profit consortium consisting of the National Community

Renaissance, Related Companies and LaBarge Industries. The City intends to close on the site and negotiate the terms of an affordable housing agreement for consideration by the City Council.

Adjacent to the Metrolink station, the General Plan and the Downtown Vision Plan designate the site for mixed-use or transit-oriented development. The San Bernardino County Transportation Commission proposes a second rail track for Metrolink in the future. By purchasing the parcels, the City/RHA intends to incorporate easements connecting the Metrolink Station to Bonnie View Drive for future residential projects in anticipation of the second rail track.



City Council Approves Sale of Successor Agency Parcels

On July 14, 2015, the City Council, acting for the Successor Agency to the Former Redevelopment Agency, approved the sale of 4 Successor Agency parcels to Panattoni Development. Panattoni proposes to develop a distribution center of 540,000 square feet on a 23.4-acre site. The site is located west of Alder Avenue, between Walnut Avenue and south of Renaissance Parkway. The four Successor Agency parcels total 4.1 acres and will be sold for the appraised fair market value of \$1,409,256. The City will receive about 14% of the sale proceeds, or about \$200,000, in additional property taxes with the balance distributed to the County, local schools, and various other taxing entities.

Hot Car Safety - Reminder!

Although experts often focus on more common safety measures, like using car seats correctly and basic childproofing, there are many less well known 'hidden dangers' that may put your kids at risk.



Your family car is one of these 'hidden dangers,' and it is not just because of car accidents. In addition to the risk of getting hit or run over by a car, being left or getting trapped in a hot car can be just as deadly a danger. In fact, at least 600 children have died after being left in a hot car, sometimes on relatively mild days with only 70 degree temperatures, since 1998.

On a typical summer day, the temperature inside a car, even with the windows rolled down a little, can quickly rise above 120 to 140 degrees. Even on a relatively mild day, the temperature inside a car can get above 100 degrees. At those temperatures, kids are at great risk for heat stroke, which can lead to a high fever, dehydration, seizures, stroke and death.

City of Rialto False Alarm Program

The City of Rialto now offers online access to the False Alarm Program. The City of Rialto Municipal Code sections 7.01.010 through section 7.01.090 outline the requirements for use of alarm systems in the City. These municipal code sections describe the alarm permit requirements, fees, exceptions, and penalties for excessive false alarm responses. All owners of burglary, robbery, and/or fire alarms operating within the City of Rialto must possess a permit for said alarm(s). Additionally, all alarm permits must be renewed annually. DUI Checkpoint

On Friday, July 24, 2015, the Rialto Police Department Traffic Unit conducted a DUI/Driver License checkpoint in the 1400 Block of Foothill Boulevard. Of the 1,211 vehicles that entered the checkpoint, 693 persons were screened further for possibly being DUI or being unlicensed. Eight arrests were made; three for DUI, two for other felonies, and three for outstanding warrants.



Funding for this and other DUI checkpoints is provided to the Rialto Police Department by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

Coming Soon - New Property Identification Program!

The Rialto Police Department will be introducing a new program to help track and recover stolen property. This technology will be part of a comprehensive crime prevention solution to assist in the reduction of property crime. The technology allows for identifying information to be applied to anything and it will not come off, protecting your property. Stay tuned for more information!

Fireworks Enforcement

The Fire and Police Departments conducted fireworks enforcement from July 3-5. As a result, approximately 1,500 pounds of illegal fireworks were seized and a total of 73 citations were issued.



Evidence-Based Policing Hall of Fame

On August 18, 2015, Chief Tony Farrar will be inducted into the Evidence-Based Policing Hall of Fame from the George Mason University Center for Evidence-Based Crime Policy. This accomplishment requires that the inductees not only have been central to the implementation of a documented rigorous scientific evaluation of police practices, but also requires a consistent record of incorporating evidence-based practices in policing. Fire Department

Fourth of July Activities: Good Progress in Stopping Illegal Fireworks

As in previous years, the Fire Department was heavily involved this year with activities related to the community's celebration of Independence Day. These activities included monitoring the sale and use of Safe & Sane Fireworks, arranging for and permitting a professional fireworks display for the City's 4th of July event, investigation of illegal firework use, public education and enforcement of illegal firework laws and ordinances, and enhanced response to emergency call volumes that typically occur on Independence Day. Here's a breakdown of the RFD's activities:

- A total of 25 Safe and Sane fireworks booths were permitted and inspected by our fire prevention personnel. These booths sell only fireworks that are approved for safe consumer use by the California State Fire Marshal. Each booth is run by a non-profit organization that is located here in Rialto. These booths are a significant source of revenue for these non-profits, who in turn use the proceeds to invest back into programs that benefit our community members.
- The Fire Department provided logistical support and coordination for the City's professional fireworks show held on the 4th. Because fireworks demonstrations of this magnitude must be inspected and permitted by the Fire Department, our staff attended specialized training for this function to make sure that we had a safe and entertaining show.
- The Fire Department provided approximately 900 yard signs that featured the \$1,000 penalty for the possession or use of illegal fireworks. We appreciate the support of our community members in getting this word out. Based on the outcome of our enforcement efforts, your participation made a difference!
- A total of 73 citations were issued by Rialto Police and Fire personnel. Collections for these fines could bring in as much as \$73,000.
- Approximately 3,200 pounds of fireworks were confiscated through the enforcement effort. These fireworks will be turned over to the State Fire Marshal's office to be destroyed.

Each year, the City makes progress in reducing the use of illegal fireworks within our City. Rialto Police and Fire will continue with innovative ideas and an intensified effort each year. Below is a chart showing the progress in 2015 compared to the previous year.

Mutual Aid Activity

A fast moving vegetation fire broke out this month causing a complete closure of Interstate 15 in the Cajon Pass. Your Rialto firefighters were called upon to assist in this incident, referred to as the North Fire. One fire engine and one Battalion Chief were deployed to assist in structure protection. The fire destroyed 7 homes, 16 outbuildings, and 44 vehicles while consuming 4,250 acres. Fire resources from throughout San Bernardino County, including your Rialto firefighters, were able to fully contain this fire in three days. This fire qualified for a Fire Management Assistance Grant submitted through the Governor’s Office of Emergency Services. Through this grant the City will be reimbursed for costs associated with providing this assistance to our neighbors. Your firefighters gained valuable experience and built upon existing relationships with our local state and federal firefighting partners which are always of benefit when we call upon them for assistance in Rialto.



Community Training

The Rialto Fire Department and the dedicated volunteers of the Rialto Community Emergency Response Team (CERT) Program conducted the third 2015 CERT training module in July. The Rialto CERT program educates people about disaster preparedness for hazards that may impact their area and trains them in basic disaster response skills, such as fire safety, light search and rescue, team organization, and disaster medical operations. The Rialto Fire Department is proud to support the efforts of your Rialto community members in their efforts toward disaster preparedness, and bring resiliency to the City of Rialto.



CPR and Basic First Aid Training

Would you know how to help if someone was injured or needed CPR? One of the most important steps that you can take to help your family and friends in a time of need is to learn these basic skills that you can use before the Fire Department arrives. To help with this, the Rialto Fire Department is offering CPR and basic first aid classes for members of our community. Classes will be held on the third Thursday of each month at Fire Station 203, located at 1550 N. Ayala Drive.



The classes are offered in two sessions. The CPR class is taught by our certified instructors from 8:00 am to 12:00 pm. Upon successful completion, you will receive Basic Life Support CPR certification card from the American Heart Association. The cost of the class is \$50.00 which covers all required manuals, AHA certification costs, and your own one-way pocket mask that is used to deliver breaths when performing CPR.

The basic first aid portion of the training then picks up from 1:00 to 4:00 pm. This class uses standardized curriculum to give the student the ability to properly deal with a variety of medical and traumatic events. The cost of this class is \$20.00 which includes the instruction, hands-on training, and student manual.

Keeping Things Safe and Fun This Summer



Some of the hallmarks of summer include great weather, friends, and backyard barbecues. Outdoor grilling can be tasty, but like any other process that uses an open flame, injuries and damage can occur if you are not careful. Knowing a few fire safety tips and following instructions will help everyone have a safe summer.



- Use Barbecue Grills Safely

- Never leave a barbecue grill unattended.
- Place the grill well away from siding, deck railings and out from under eaves and overhanging branches. Don't use or store on a porch or balcony.
- Keep children and pets away from the grill area. Have a 3-foot "kid-free" zone around the grill.
- Put out several long-handled grilling tools to give the chef plenty of clearance from heat and flames when cooking food.
- Periodically remove grease or fat buildup in trays below grill so it cannot be ignited by a hot grill.
- Use only outdoors! If used indoors or in any enclosed spaces such as tents, barbecue grills pose both a fire hazard and a risk of exposing occupants to carbon monoxide.

- Charcoal Grills

- Purchase the proper starter fluid and store out of reach of children and away from heat sources.
- Never add charcoal starter fluid when coals or kindling have already been ignited, and never use any flammable liquid other than charcoal starter fluid to get the fire going.
- Dispose of charcoal coals only after they are cool. Empty the coals into a metal container with a tight-fitting lid that is used only to collect coals. Place the

container away from anything that can burn. Never empty coals directly into a trash can.

Public Works

Water Conservation Ordinance Update

Meeting California's Conservation requirements will take hard work and your help! The States reservoirs have been consistently depleting since 2011.

On July 14, 2015, the Rialto City Council conducted the second reading of the proposed changes to the Water Conservation Ordinance. In addition, City staff will be recommending that the City Council declare a Stage 3 Water Warning for Rialto Water Service customers at the August 11, 2015 Council Meeting. At that time, if approved, the changes will go into effect on August 13, 2015. These additional State required conservation measures are necessary to help the City of Rialto meet the 28% reduction in water use. West Valley Water District has already implemented this Stage 3 restriction for their customers.

What do these requirements mean to Rialto Water Services and West Valley Water District customers?

All of stage 1 and stage 2 restrictions still apply. In addition, Stage 3-A restrictions will be in effect. Below are the restrictions for Stage 3-A. By making these changes, and cutting your outdoor water use in half, you will be playing an important part in building a sustainable future.

Stage 3 – Water Warning


Stage 3 means that the City is not able to meet all water demands of all water customers, or, the state of California has adopted regulations requiring the City to implement requirements and actions of a Stage 3 water warning regardless of the City's local water supply, and the following water conservation measures shall apply:

1. All customers are required to reduce water consumption by a minimum 25%.
2. All landscape irrigation water shall be limited to no more than three days per week for no more than ten minutes per station per day.
3. Prevent water waste from runoff, breaks and leaks.
4. Sweep hardscapes rather than using a hose.

5. Use a recirculator if you have a fountain or water feature.
6. Repair leaks within 48 hours of notification.
7. Do not fill swimming pools, ornamental ponds, fountains, water displays, hot tubs, spas and artificial lakes after being drained.

Water Conservation Classes - FREE Landscape Class

A free class on how to make your yard efficient and beautiful is being offered on Saturday, September 26, 2015 from 9:00 am to 12:00 pm at the West Valley Water District located at 855 W. Base Line Road. Topics will include irrigation efficiency improvements, turf removal and sheet mulching, climate appropriate/water efficient plant and landscape materials and tree watering. Each attendee will receive a water saving device and have a chance to win a weather based irrigational controller or rain barrel. REBATES to Help You Save Money and Water

High Efficiency Irrigation Nozzles = \$4 PER NOZZLE REBATE

Shut Off Nozzle = \$10 PER NOZZLE REBATE
