



CITY OF RIALTO BURIAL ASSISTANCE

PROGRAM OVERVIEW

The City of Rialto (City) has approved a Burial Assistance Program (Program) to assist City residents affected by the COVID-19 pandemic. The Program provides a maximum one-time reimbursement of up to \$5,000 per household that has had an immediate family member suffer a COVID-19 related death. The Program will help cover funeral expenses and interment or cremation. Reimbursements can be requested for funeral expenses from March 27, 2020 to the present. To submit a request for reimbursement, please visit the City’s website at www.yourrialto.com/RialtoAssistancePrograms.

Applications will be accepted and processed on a first come, first served basis until all funds are expended.

WHO IS ELIGIBLE TO REQUEST BURIAL REIMBURSEMENT?

To be eligible, applicants must meet all program requirements as outlined below:

- Applicant must be a City of Rialto resident; **and**
- The applicant’s residential address must be within a qualified census tract **OR** demonstrate that they meet income eligibility per the U.S. Department of Housing Urban Development 2022 Income Limits (see below).

WHO IS CONSIDERED AN ELIGIBLE FAMILY MEMBER FOR PURPOSES OF THIS REIMBURSEMENT?

- An immediate family member that suffered a COVID-19 related death is eligible for reimbursement. An “immediate family member” is defined as mother, father, spouse, domestic partner, brother, sister, children, grandparent, grandchildren, stepparents, stepchildren, and stepsiblings.

WHAT DO I NEED TO DO IN ORDER TO REQUEST A BURIAL REIMBURSEMENT?

- Complete and submit the Burial Reimbursement Request Form and attach a copy of the receipt(s) that shows proof of payment to the licensed funeral, cremation, or cemetery provider. Receipt(s) must include the following:
 - Name of the deceased;
 - Date of receipt and payment; and
 - Total amount paid for funeral/cremation services.
- Required documents to be submitted with Request for Burial Reimbursement:
 - Copy of Government Issued Photo Identification (I.D). **OR** utility bill if I.D. does not have Rialto address;
 - W-9 Form (will be provided by staff if approved);
 - Copy of Death Certificate; and
 - Any additional requested information or documentation as determined by the City.

WHERE DO I SUBMIT A BURIAL REIMBURSEMENT REQUEST AND SUPPORTING DOCUMENTATION?
