BOOTH REGULATIONS

- **EVENT HOURS:** 10:00 a.m. until 1:00 p.m. on Saturday, September 17th
Tear down may begin at 1:00 p.m. on Saturday

- **SET UP TIMES:** Saturday, September 17th *7:00am – 9:00am*

All vendors must be in place by 9:30am Saturday, September 17th. Locations will NOT be reassigned. For safety purposes, no vehicles may drive onto any grass area at the event location. **Violators will not be invited back.** Please be prepared to transport your items from your vehicle (parking lot) to your booth space.

- **BOOTH LOCATIONS:** Each vendor will be assigned a booth location. A final event map will be sent to each vendor 5 days before the event.

- **BOOTH SPACE:** Vendor spaces are outside and on grass and/or pavement. Vendor Booths MUST be self-contained. Please bring all necessary materials, chairs, tables, shade coverings, etc. The City will NOT provide these items.

**** Electricity will NOT be provided****

- **PRODUCTS:** All merchandise must be suitable for a pet and family-type atmosphere. Second-hand merchandise may not be sold. The City reserves the right to stop the sale of any item deemed inappropriate.

- **LIABILITY:** The City of Rialto is not liable for theft or damage.

- **LIMITED PARKING:** Parking at Event (City Hall) is limited. There will be parking at empty dirt lots near the event. Handicap parking spots are available on city streets. The City will not provide reserved parking.

- **FEES:** Payment must accompany Booth Application. Please make check payable to City of Rialto. Submit to Rialto City Clerk's Office, 290 W. Rialto Ave., Rialto, CA 92376. **No Refunds.**

INFORMATIONAL NON-PROFIT/FUNDRAISING GROUPS

Informational spaces are **\$10.00**. We ask that you bring plenty of items to give away. In order to reserve your space at the Event you must submit a Booth Application. Copy of non-profit status if applicable.

MERCHANDISE VENDORS

Merchandise vendor spaces will be on first come, first serve basis. Vendor space is **\$25.00**. In order to reserve your space at the Event you must submit BOTH City of Rialto Special Events Application and Event Booth Application.

- **One Day Event Permit:** All Vendors who will be selling products at the Event are required to complete a separate one day Special Events Application. Fees are already included in Event Application Fee.
